As a consequence of the late supply or defective goods delivered by the Supplier, the buyer is entitled to impose a delay penalty. The time of the penalty imposed will start with the first working day following the confirmed deadline. The measure of the penalty will be calculated on the basis of the value of the concerned commodity, daily 0,5%. In case of qualitative objection, the delay penalty will be imposed up to the replacement of the defective goods. In case the replacement of the defective goods should be carried out within 3 working days after the delivery on the Supplier's cost, so he will be exempted from the requirement of payment of penalty. Customer is entitled to enforce his rights to indemnity concerning his damages exceeding the sum of the penalty - taking the value of the not used goods, the concerning production costs, as well as the costs of the delivery and re-transportation into consideration - towards the supplier, if it can be explicitly determined, that Supplier can be held responsible for the qualitative problem. Further customer is entitled to charge the Supplier with all his obligations of penalty payment and other damages, even when supplier replaced the defective goods within 3 working days.

We take over goods only in case if on the package (collective package or transport package) the shelf-life is unambiguously described (Remark: The label statement of the time of production as well as the production item identification number are allowed).
